Thank you for considering YMCA Camp Ocoee to serve your family this summer. The YMCA of Metropolitan Chattanooga is a not-for-profit health and human services organization committed to helping people grow in spirit, mind and body. The YMCA is here to serve people of all ages, backgrounds, abilities and income. We are community-based and believe that our programs and services should be available to everyone. That's why the YMCA offers Camp for ALL.

Volunteers in the YMCA raise funds for our annual Community Support Campaign. Funds are used for providing funding to youth and families who need of assistance.

To qualify for Camp for ALL, you must meet the following guidelines:

- Funding is awarded for a camper to attend up to 2 camp sessions per summer.
- Proof of Income (most recent IRS 1040 form (first 2 pages) or pay stubs, etc...)
- Extenuating circumstances may be taken into consideration, but must be documented on the application. If the parent or guardian is enrolled in college or trade school, a copy of your enrollment must be included.
- **No additional discounts will be applied.**
- How to register your camper(s):
 1. Register the child(ren) using our online registration system to ensure they have a space in the session(s) of choice, then submit your Camp For ALL application to our office for review. Please note on the application that your child(ren) are registered. A \$100 deposit is required to register online.
 2. Submit the Camp for ALL Application with the Camper Registration form. The \$100 deposit will only be required once you have accepted your funding. **The child's space in the session will not be held until we receive the deposit.**

Complete Camp For All applications will be reviewed in the order they were received, please allow up to a week for processing. You will receive an email once your application is processed with the amount of funding we are able to provide. Incomplete applications will be returned to you with a list of your missing items.
